C. Maintenance of Biscay Water System – Public Works Director Lemen Back in April, Mark Lemen was contacted by the City of Biscay about contracting services for their water distribution and treatment. There are some definite upgrades and some things that we would require prior to taking over as the contractor for work for their water system. We had discussed potentially installing meters in each home and running them as a Glencoe utility. They would like us to operate the utilities starting July 1st. They are in a pinch for time with their current contractor leaving.

 - F. Annexation of Heil Property 2170 Ford Avenue North Resolution 2024 PW Director Lemen and City Attorney Ostlund

 The residents of 2170 Ford Avenue North would like to connect to our water and sewer, they have some failing infrastructure. This would entail a little bit of collaboration with the Hospital for them to connect towards sanitary. It is a minimal expenditure. I don't know whether it would cost us anymore than what our already operating costs are. The residents would like us to move forward with the annexation.
